# **Speech CFY Issue Finally Resolved**

After a long and drawn out debate regarding whether MSP reimbursement could be obtained for Speech Therapists in their Clinical Fellowship Year (CFY), the Ohio Office of Medical Assistance has finally ruled that CFY's can bill under the Medicaid School Program. CFY services can be billed through MSP under the same billing guidelines as Occupational Therapy Assistants and Physical Therapy Assistants do, which requires the billing documentation to be co-signed by their supervising therapist. Beginning with the 2013/14 school year, we will be adding the co-signing feature to all CFY therapists.

# **MSP** Parental Consent Change

MSP Parental Consent is no longer required each time the IEP changes. Signed Parental Consent is only required one time, and is valid for the entire time the student is receiving services within the district. If the student attends another district, a new signed Parental Consent must be obtained. An annual MSP Parental Consent Notification is required to be provided to the parent that explains the parent rights under the IDEA Parental Consent.

#### MSP Random Moment Time Study (RMTS)

All MSP therapists that are employed by a school district (Non-ESC or Non-Contracted) are included in the statewide Random Moment Time Study. This time study system computes the percent of time that Ohio MSP therapists spend doing Medicaid reimbursable activities. Individuals that do not complete their time study questionnaire will generate a zero for the moment, which will decrease the overall reimbursable percentage for all districts. When you are selected for RMTS, please complete your time study.

# **Signing the IEP**

Please remember that MSP requires that the IEP be signed by each therapist that recommends the service. During the first two years of MSP audits, 90% of the audit adjustments were a result of students receiving therapy services, but the IEP was not signed by a licensed therapist. Even if you do not attend the IEP meeting, there is a place on the IEP for the therapist to sign. Therapy services should not be listed on the IEP unless they are recommended by a licensed therapist.
